A. Nomination Procedure for all Office Bearers, CC and EB Members:

1. Nomination proforma as uploaded in the IPHA website should be used.
2. The **Nomination form should be completed** in all respect.
3. Nomination of the candidate **should be proposed and signed by a valid member** of the association
4. A valid member other than the person who proposed it shall second the nomination paper and sign in it.
5. Nomination form **should accompany Brief Biodata** mentioning at least qualification, designation and important public health activities carried out by him/her.
6. The candidate should give a **self-declaration** about the post she or he is holding presently/ or served earlier with tenure. [In a separate enclosure attached]
7. The completed, **ink signed nomination form** with all enclosure in hard copy **must reach IPHA Office by hand or speed post** or by courier **within 5-00 PM on 2nd February, 2026 (Monday)**.
